

I have met with almost all of the new board members. We will continue the work of our predecessors, but we also have some changes in mind. As you have already noticed, the *Networker* has a new format and some new content. The changes are the work of Susan Kullmann Puz and Barbara Stites, our new editors. Susan does the actual layout; she and Barbara work together on content. Barbara has the task of getting the newsletter into the mail. If you have a free hour, please call Barbara. We are also looking for the best price for printing in the Los Angeles region.

Karen Lystra plans to organize our "books" and improve our bookkeeping system. In working with the IRS to make sure that our tax exempt status was in order, I found that we do need to keep more formal records than we've kept in the past. There are three co-chairs of the Program Committee: Alexandra Nickliss, Jane Bernard-Powers, and Kathie Sheldon. I expanded the committee to three members this year because we are going to do some special programming for our twenty-fifth anniversary. Based on the discussion at the business meeting at Tahoe, we are planning a special plenary session. If you have any questions or suggestions, please contact me or one of the committee members.

We are now identifying the committee members for the WAWH prize committees. If you would like to serve on any of these committees, please contact me or the committee chairs. Remember our new prize, the Kanner



Prize, which honors distinguished achievement in scholarly bibliographical and historiographical work.

Conference Coordinator Regina Lark has already made hotel reservations for the conference next spring, and has some fascinating ideas for Friday evening entertainment. But I will let her tell you all about them.

Sections of the minutes of our meeting at Tahoe are printed elsewhere, but I wanted to call special items to your attention. First, members voted unanimously to increase the sums given for the several awards. The Sierra Book Award will be \$250, the Graduate Fellowship will be \$1,000 and the Kanner Prize will be \$500. These decisions came after thoughtful discussion.

Second, the group decided to increase our dues for the first time in more than a dozen years. The group also created a lifetime membership with dues set at \$400. These dues will go into effect in January. The dues will cover some of the increases in the prizes, but we need to look to other methods of fund-raising. A number of you have not renewed your membership yet. You can tell where you stand by looking at the mailing label on this newsletter. I would hate for you not to be included in our 25th anniversary celebration because you had been dropped from the membership list.

I am working on a project to reach out to women scholars who have recently moved to the area but do not know about WAWH. Our new brochure is ready. I have developed a plan and need help. Is there anyone willing to spend time checking our membership list against the AHA directory? Please be in touch. It should not take long and a letter to each new scholar could really help to build our organization.

I am also in the process of putting together a budget for the coming year. Here, too, our bookkeepers could be most helpful.

This column turned out to be rather business-oriented. I promise I will not always use this column to report our inner workings. But I am pleased to see the work that everyone is doing and thought I should share this with all of you.

I hope your summer was relaxing and productive. And on that note I am going to return to a manuscript that I can only get to during the summer.

May 1, 1993 Stanford Sierra Camp

### Reports of the Officers

President-Elect Peggy Renner informed the members that we are now officially a non-profit, tax-exempt organization. All contributions are now tax-deductible. Peggy also reported that the 25th Anniversary Meeting of the WAWH will be held at the Huntington Library in Pasadena on May 20-22, 1994. Reservations for Asilomar have been submitted for 1995 and are still pending.

Membership Secretary Alison
Klairmont Lingo reported that 200
members whose dues have been in
arrears three or more years were
deleted from our computer files.
Those "deleted" members were then
notified that if they paid one year's
membership dues they would be
reinstated. This mailing brought
back the majority of those members

Alison also reported that a roster of all members in good standing is now available for \$2.50.

Graduate Student Representative Regina Lark reported that there was a very successful graduate student discussion group in the Los Angeles area. She mentioned the possibility of working with new Graduate Student Representative Emily Rader on establishing a graduate student paper matching network.

Susan Wladaver-Morgan, newsletter editor, reported that the *Networker* has been appearing quarterly. In addition, a special issue of the *Networker* was sent out to members to give details about the doings of the K-12 Committee on Curriculum Reform.

#### Committee Reports

Lyn Reese and Karen Offen reported that the Standing Committee on Curriculum Reform has been

invited to give a report to the Committee on the Status of Women at the AHA in January. We will also need to follow-up our initial contact with AAUW; they are conducting a two-year study on gender and the class-room. They would appreciate input from us on how to integrate this focus with our concerns about history curriculum.

National History Standards are a big issue right now. We must take a position on the standards now being promoted. These standards must be decided by 1994. Goals: require that the world and U.S. histories of women be integrated as much as possible into the main historical narrative; insist that women's history scholars, including those with knowledge of non-western histories be represented in the standards setting process. (A letter to the National History Center, Secretary of Education Richard Riley and his deputy Madeleine Kunin would be most helpful.)

Penny Kanner, WAWH Liaison with other organizations, reported on several institutions that she serves as an advisory board member:

The Park Library in Los Angeles has taken a serious interest in gender and history; WAWH members are welcome to make suggestions for programming.

Several WAWH members serve the Huntington Library's Women's Studies Seminar; Penny wants to see programs with more historicity. [Editor's note: The next seminar will be on Sat., October 23, 1994. It will focus on Autobiographical Playwriting, Information: (818) 405-2190]

The Library Committee of the California Historical Society has purchased new property. There are many women's historical sources available at the present time.

Jean MacDonald has put WAWH membership applications at the Women's Heritage Museum and asks for more WAWH participation.

#### **New Business**

California Southern Scholars Group has donated \$950 to the WAWH graduate student fund to help graduate students attend our annual meetings.

WAWH prize awards and member dues will increase. The Sierra Prize Award will increase to \$250 from \$100; the Graduate Student Fellowship to \$1,000 from \$750. (The new \$500 Kanner Prize is funded

independently.)

Dues will raise slightly in 1994 to support all of the work and awards that WAWH is undertaking. Annual full-time employed dues will increase from \$15 to \$20, part-time and retired from \$10 to \$15, and graduate student and independent scholar from \$5 to \$8. A new category is available: Life Membership for \$400.

Each of the following awards is granted at the annual conference of the Western Association of Women Historians. Authors must be members of WAWH at the time of submission. The 1994 deadline for all submissions and applications is February 15, 1994.

#### Sierra Prize

The WAWH will award the 1994 Sierra Prize (\$250) for the best monograph published by a WAWH member. Eligibility for the prize is limited to two groups: those residing in California, Oregon, Washington, Hawaii, Alaska, Idaho, Utah, Nevada, Arizona, New Mexico, Colorado, Wyoming, Montana, Texas, or Oklahoma; and WAWH members residing in other states who have paid membership for three years (not necessarily consecutive). The book must be a monograph based on original research (not an anthology or edited work); the prize is open to all fields of history. ## **Barbara Penny Kanner Award**

The WAWH will award the first Barbara Penny Kanner Prize (\$500) to the best scholarly bibliographical and historical guide to research focused on Women's or Gender history. This award is intended to promote the practice of bibliomethodology, and to reflect the critical tools of the historian's craft as they have been developed to provide research guides. Book-length submissions are preferred but substantial guides in other forms (articles or book chapters) may also be considered. I can only list a small number of funding sources here. Particularly useful volumes include Annual Register of Grant Support: A Directory of Funding Sources, 26th edition (1993); Directory of Financial Aids for Minorities, 1993-1995; Directory of Financial Aids for Women, 1991-1992; Directory of Grants in the Humanities 1992/93, 6th edition; Directory of Research Grants (1992).

A handy way of learning about possible sources of funds is through two databases that you can connect with through your university. One is the Stanford University Awards Database which contains descriptions of graduate-level fellowships, research opportunities, and independent-project funding offered by institutions or foundations throughout the world. A similar but much larger database is provided by the University of Washington. If your university doesn't have information, write to the institutions directly.

A free computerized service called FEDEX provides information of government agency research opportunities and funding. Participating agencies include the Departments of Energy, Commerce, Education, and HUD; NASA: FAA and others. ## GRAD NEWS

Now is the time to start working on getting money to help you get through next year. Deadlines for different grants and awards occur all through the year, but October 1 through April is a particularly busy period. Remember that most grants and fellowships require that a student be advanced to Ph.D. candidacy.

If you are thinking of taking out a loan to help you through your coursework or dissertation, don't make the same mistake I did last spring: I missed the deadline to apply for financial aid. If you are not already aware of student loan programs, contact your university's financial aid office for information, applications and deadlines. The federally-sponsored student loan program is available to all students who are attending classes at least half-time. These loans do not have to be paid back until six months after your coursework is completed, and they carry interest rates below typical bank loan rates. In California, the deadline is in the spring.

There is a new network, WEB, which is especially geared to helping graduate students form panels at conferences by finding other potential presenters. While all scholars are invited to participate in WEB, graduate students are particularly encouraged to apply. Write to me for a form. (See WAWH officers list.) The information you submit on your returned form will be entered into a computer database. At present, if you want to request information so you can contact other presenters in order to form a panel, you must contact me through the mail, but WEB will be available on e-mail soon. I am happy to say that I received 10 completed WEB forms from people who picked them up at the PCB-AHA conference in August.

The 4th Annual American Studies Graduate Student Conference is scheduled for April 1–2, 1994. Proposals for panels or papers on any topic dealing with American culture, or on pedagogy, professionalism, and graduate student life are welcome. Send a one-page abstract or

# Historians and the Electronic Highway

There are about 84 electronic discussion groups devoted to some aspect of history. The following is excerpted from H-Net and describes its 21 scholarly lists for historians.

H-Net is an initiative of the History department at the University of Illinois, Chicago, to assist historians to go online, using their personal computers.

H-Net sponsors 21 electronic discussion groups or "lists." Sub-

scribers automatically receive messages in their computer mailboxes. These messages can be replied to, saved, discarded, downloaded to a PC, copied, printed out, or relayed to someone else. The lists are free newsletters that are published daily.

Currently our lists have 4,300+ subscribers (2,800+ separate people) in 40 countries. They receive an average of 15-50 messages a week. Membership is open to any scholar or graduate student, and is free. (We

especially welcome librarians and archivists.) Each list is moderated by a historian and has a board of editors. The moderators control the flow of messages and reject those unsuitable for a scholarly discussion group.

The primary purpose of each list is to enable scholars to easily communicate current research and teaching interests; to discuss new approaches, methods and tools of analysis; to share information on electronic
